Water damage restoration remains a central focus of the expanded operations. The company handles house

flooding, appliance leaks, burst pipes, drywall and floor damage, water extraction, structural drying, flood damage restoration, and sewage cleanup. Teams respond quickly to stop leaks, extract standing water, and begin the drying process to help prevent mold growth, lingering odor, and structural deterioration.

Beyond water-related emergencies, the company provides fire damage restoration, including smoke and odor removal and the removal of hazardous debris. Additional services include mold remediation, mold inspection, thermal imaging to detect hidden moisture, lead removal, asbestos removal, and home remodeling. As a licensed general contractor, the company also offers reconstruction and major repairs, allowing properties to be restored from initial cleanup through final rebuild.

The company follows a structured approach to each project, beginning with emergency contact and arrival, followed by inspection and damage assessment, water extraction, drying and dehumidification, and reconstruction where needed. This process applies to both residential and commercial properties throughout the service area.

"Restoration work involves more than removing water," Losonczi added. "It requires certified professionals, proper equipment, and attention to indoor air quality and structural safety. The expanded coverage reflects a commitment to bringing that level of service to every community in the county."

Revival Water Damage Restoration of Orange County operates 24 hours a day, seven days a week, and offers a free inspection. The company works with all insurance providers and provides financing and out-of-pocket pricing upon request. Certified specialists use advanced drying and purification equipment to restore properties and improve indoor air quality following water intrusion, fire, or mold events.
